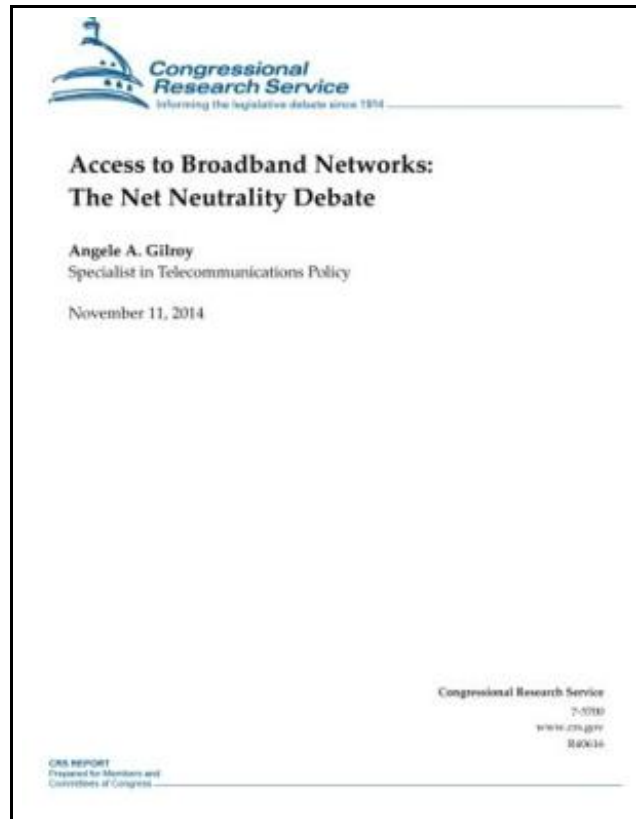

The move to place restrictions on the owners of the networks that compose and provide access to the Internet, to ensure equal access and non-discriminatory treatment, is referred to as net neutrality. While there is no single accepted definition of net neutrality, most agree that any such definition should include the general principles that owners of the networks that compose and provide access to the Internet should not control how consumers lawfully use that network, and they should not be able to discriminate against content provider access to that network. A major focus in the debate is concern over whether it is necessary for policy makers to take steps to ensure access to the Internet for content, services, and applications providers, as well as consumers, and if so, what these steps should be. Some policy makers contend that more specific regulatory guidelines may be necessary to protect the marketplace from potential abuses which could threaten the net neutrality concept. Others contend that existing laws and policies are sufficient to deal with potential anti-competitive behavior and that additional regulations would have negative effects on the expansion and future development of the Internet. The January 2014 decision by the U.S. Court of Appeals, D.C. Circuit (Verizon Communications Inc. v. Federal Communications Commission, D.C. Cir., No.11-1355) upholding the Federal Communications Commission's (FCC) authority to use Section 706 of the Telecommunications Act of 1996 to regulate broadband providers, but striking down the specific anti blocking and nondiscrimination rules of the FCC s...
